## Bartlett Park District Riley's Run Dog Park Rules

**Hours of Operation:**                      **Daily, year-round  
Sunrise to Sunset**

**All patrons of Riley's Run Dog Park must follow the rules and regulations that have been established to promote the safe and enjoyable use of this facility.**

### **Park Usage Guidelines:**

- No more than 2 dogs per person on any one visit.
- Dog owners/handlers must be at least 12 years old.
- Children must be closely supervised by a responsible adult and will be expected to behave in an appropriate manner: no running, no chasing dogs, no petting of other dogs unless permission is requested from the owner/handler first.
- Access to Riley's Run Dog Park is limited to healthy dogs:
  - For whom a current Riley's Run Dog Park permit has been purchased, which includes *written* proof of:
    - Examination for communicable diseases within one year of the permit application date
    - *Current* vaccinations for rabies (dogs must wear rabies tags), DHPP, Bordetella and Leptospirosis
    - A negative stool specimen within 120 days of the permit application date
- Dogs must be on a leash when entering and leaving the gated area of Riley's Run Dog Park. They may be taken off the leash while within the dog park, except as necessary for the safety of the dog or patrons.
- Collars must be worn at all times (no pinch or spike collars allowed).

### **Owner's Responsibilities:**

- Dog owners/handlers are legally responsible for their own dog(s) and any injuries caused by their dog(s)
- Dog owners/handlers and their dog(s) participate in using Riley's Run Dog Park at their own risk.
- Dog owners/handlers are solely responsible for determining if they and their dog (s) are physically fit and/or adequately skilled for activities that they may participate in at Riley's Run Dog Park.
- Owners/handlers are responsible for closely supervising their dogs, and at no time should an owner/handler leave the area without their dog(s).
- Dog owners/handlers must wear their Riley's Run Dog Park permit on its lanyard at all times when in the park and it must be visible to everyone.
- Dog owners/handlers must keep their dog's leash with them at all times and leash their dog(s) immediately if aggressive behavior is observed.
- Dog owners/handlers are required to pick up dog feces *immediately* and dispose of it in the waste receptacles located throughout the park.
- Dog owners/handlers are required to cover any holes their dog(s) digs.

### **Other:**

- Violation of rules will result in loss of park privileges with no refund.
- A \$5.00 replacement fee per permit will be charged for replacement permits.
- Permits for Riley's Run Dog Park are to be used only for the registered dog(s). Permits used illegally will result in fines charged to the dog owner/handlers and/or revocation of the permit.
- Permits expire one year from the date of issue.

### **The following are prohibited in Riley's Run Dog Park:**

- All dogs known to be aggressive toward other dogs or people are prohibited in the park.
- Persons *not* engaged in dog-related activities.
- Food, treats, rawhide
- Muzzled dogs
- Dogs in heat
- Bikes
- Devices that use an explosive force to propel a retrievable object
- Animals (dead or alive) for training purposes

### **Riley's Run Dog Park Closings:**

- When thunder or lightning is heard or seen.
- Inclement weather
- As determined necessary by the Bartlett Park District

**PEOPLE WHO DO NOT FOLLOW RULES WILL BE FINED AND/OR HAVE PERMIT(S) REVOKED.**

Bartlett Park District reserves the right to add or modify these rules as needed.
